#### **MISCELLANEOUS RESOLUTION**

Resolution No. 405-14
Introduced in Council

WHEREAS: The City of Charleston and surrounding communities have experienced an unprecedented

emergency associated with unsafe drinking water due to the recent chemical spill; and

WHEREAS: The resulting closures of businesses have resulted in reduced patronage of local employers during

the water emergency and have adversely affected not only those businesses, but just as

importantly, the employees who depend on this work for their daily livelihood; and

WHEREAS: This water emergency has had a particularly devastating impact on service sector employees in

many restaurants, hotels, hair salons, laundry cleaners and other similar businesses that need to use

water in their daily commercial activities; and

WHEREAS: In response to disruption of business and impact on service sector employees, several

organizations and individuals have launched a number of initiatives to encourage people throughout our community to identify and patronize local businesses that have returned to

conducting normal, safe services; and

WHEREAS: These initiatives include East End Main Street's "Rehydrate" campaign, the West Side Main

Street promotion, "Eat West, Shop West, Go West," the grass roots effort to "Turn Up the Tips" to help servers make up some of the income they lost because of the water crisis, and the Charleston

Area Alliance's "#Back2BizCWV" campaign; and

WHEREAS: Restaurants in Charleston and the rest of the affected area have worked hard to reopen safely and

to return to operations as quickly and effectively as possible, given the challenges they and their

employees have faced over the past few weeks.

**NOW, THEREFORE BE IT RESOLVED** by the elected leaders of Charleston, that we do hereby proclaim the week of January 27 to February 1, 2014 to be

#### **COMMITTEE ON FINANCE**

Councilperson Robert Reishman, Chairperson of the Council Committee on Finance, submitted the following reports:

1. Your committee on Finance has had under consideration Resolution No. 400-14, and reports the same to Council with the recommendation that the resolution do pass.

Resolution No. 400-14- Authorizing the Mayor to sign and submit all related documents for the change of scope for Community Participation Grant Program No. 13LEDA0480, West Virginia Humanities Council. The grant was initially awarded to be used for façade renovations and restoration to windows in the MacFarland-Hubbard House. The West Virginia Humanities Council requests a change in scope to apply the funds to address flooring restorations."

# Be it Resolved by the Council of the City of Charleston, West Virginia:

That the Mayor is hereby authorized and directed to sign and submit all related documents for the change of scope for Community Participation Grant Program No. 13LEDA0480, West Virginia Humanities Council. The grant was initially awarded to be used for façade renovations and restoration to windows in the MacFarland-Hubbard House. The West Virginia Humanities Council requests a change in scope to apply the funds to address flooring restorations.

Councilman Reishman moved to approve the Resolution. Councilman Lane seconded the motion. With a majority of members elected recorded thereon as voting in the affirmative the Mayor declared Resolution 400-14 adopted.

2. Your committee on Finance has had under consideration Resolution No. 401-14, and reports the same to Council with the recommendation that the resolution do pass.

Resolution No. 401-14 - Authorizing the Mayor or City Manager to sign Change Order No. 1 with Michael Baker Jr., Inc. to develop Storm Water Pollution Prevention Plans (SWPPP), in compliance with the City's Storm Water Permit #WV0116025, for twenty-four (24) Municipal Industrial Sites not previously included in the Long Term Storm Water Comprehensive Plan, at a cost of \$89,100.00. The change order includes the option to identify and perform site assessments at ten (10) additional sites for costs up to \$11,500.00 to determine if a SWPPP is warranted for any particular site, with the total cost of this change order not to exceed \$100,600.00."

Be it Resolved by the Council of the City of Charleston, West Virginia:

That the Mayor or City Manager is hereby authorized and directed to sign Change Order No. 1 with Michael Baker Jr., Inc. to develop Storm Water Pollution Prevention Plans (SWPPP), in compliance with the City's Storm Water Permit #WV0116025, for twenty-four (24) Municipal Industrial Sites not previously included in the Long Term Storm Water Comprehensive Plan, at a cost of \$89,100.00. The change order includes the option to identify and perform site assessments at ten (10) additional sites for costs up to \$11,500.00 to determine if a SWPPP is warranted for any particular site, with the total cost of this change order not to exceed \$100,600.00.

3. Your committee on Finance has had under consideration Resolution No. 402-14, and reports the same to Council with the recommendation that the resolution do pass.

Resolution No. 402-14 - Authorizing the Mayor or City Manager to enter into an agreement with HealthSmart Preferred Care and Accel Networks providing for expanded network coverage in healthcare services for City employees at a cost of \$5.00 per employee per month. The agreement is for a one year period from January 1, 2014 to January 1, 2015, with automatic annual renewals unless a 60-day termination notice is given by either party."

Be it Resolved by the Council of the City of Charleston, West Virginia:

That the Mayor or City Manager is hereby authorized and directed to enter into an agreement with HealthSmart Preferred Care and Accel Networks providing for expanded network coverage in healthcare services for City employees at a cost of \$5.00 per employee per month. The agreement is for a one year period from January 1, 2014 to January 1, 2015, with automatic annual renewals unless a 60-day termination notice is given by either party.
