- 1.1 Scope. These rules and regulations set forth the manner and conditions for the permitting and licensing of boaters to safely utilize designated electric power sources while docking at Haddad Riverfront Park

§ 2. Definitions.

2.1 "2011 Calendar Year" means those events starting on the following days:

May 24

June 1, 8, 15, 22, 29

July 5, 13, 20, 27

August 3, 10, 17, 24, 31

September 6

October 4

Other events may be added at the discretion of the City Manager

2.2 "Single Event" means only one of the events identified as part of the 2012 Calendar Year or another discrete event of limited duration designated by the City Manager as such.

§ 3. License for Hook-up; Fees

- 3.1 A person seeking a license to hook-up to a City provided power source shall make application in the City Manager's office during the hours of 8:30 a.m. through 4:30 p.m., Monday through Friday, excluding holidays.
- 3.2 In addition to the application, the applicant shall provide copies of a photo identification and a current certificate of liability insurance showing coverage of not less than \$100,000.00 per occurrence.
- 3.3 No license shall be issued unless applicant also enters into an indemnity, defense, and save harmless agreement with the City.
- 3.4 Fees shall be as follows:

3.4.1 Single event: \$25.00 3.4.2 Calendar year: \$100.00

- 3.5 No license shall be issued unless and until the power system and breaker box on the watercraft and the cord have been inspected and approved by the City Construction Project Manager or his designee.
- 3.6 The license shall be limited in duration and not extend beyond the dates identified thereon.
- 3.7 The license shall extend a privilege and not a right. This privilege may be denied, suspended, or revoked at any time, for any reason, or no reason, by the City Manager or his designee, without a corresponding refund of fees.
- 3.8 The certificate of limited license shall be kept on the watercraft at all times and shall be exhibited upon request of any City employee.
- 3.9 The limited license for electricity hook-up does not entitle licensee to preferential docking or berthing rights, although the City may, in its discretion, reserve space along the levee for licensees on a first come first serve basis.

§ 4. Connection to City provide power source; conditions.

- 4.1 Access to power shall be by receptacles located on a Dog Box approved or provided by the City. Receptacles shall be addressed by number and assigned to specific licensees.
- 4.2 Approved cords shall be tagged at the male end with a label supplied by the City. The label tag shall indicate and correspond to the number address of the assigned receptacle. A licensee may only plug into an assigned receptacle. Cords or connections with multiple extensions are prohibited.
- 4.3 Access to receptacles shall be limited to licensees only. To gain access to an assigned receptacle, the licensee must hold a valid Electricity Hook-Up License and have their boat ready to be hooked-up at 12:00 noon, 3:00 pm, or 6:00 pm boats will not have access to electric hook-up at any other times.
- 4.4 A licensee shall not, under any circumstances, permit any other individual, boater, or other water craft to hook into or use licensee's Approved Cord, including the making of any "daisy-chain" from licensee's water craft to another.
