PROJECT GOALS

• To commission a strong mural concept that captures the unity of the community and space

AUGUST 10, 2025 - FINAL CONCEPT DUE

SEPT 15 2025 - FINAL INSTALLATION COMPLETE

COMPENSATION

Artist will be paid \$5,000.00 for final rendered concept and final execution.

ELIGIBILITY

Candidates must be professional artists or designers, eligible to work in the United States, and age 18 or older. Candidates are eligible regardless of race, color, religion, national origin, gender, gender identification, military status, sexual orientation, marital status, or physical ability. You do not need to be a resident of Charleston or the state of West Virginia to make a submission.

SUBMISSION REQUIREMENTS Submissions MUST include:

- WORK SAMPLES: 3-5 images of previous work (single .jpgs or PDFs –do NOT combine)
- 2. Brief resume including related Public Art experience

INCOMPLETE SUBMISSIONS WILL NOT BE CONSIDERED

SELECTION CRITERIA

- Clarity of design
- Color choices
- Originality

SELECTION PROCESS

A selection committee will consider artists based on work sample and qualifications submitted. Selected artist(s) will be invited to submit final concept for selection and final execution.

OTHER CONSIDERATIONS:

Element Federal Credit Union shall retain ownership of the image, including but not limited to, reproduction rights, physical maintenance and lifespan. In all uses of the image, the creative product will be credited to the artist. All terms & conditions will be laid out in a contract to be signed by the artist upon selection of the artist.
