## CALL TO ORDER

The Council met in the Chambers of the City Building at 7:00 P.M., for the first meeting in the month of October on the 2<sup>nd</sup> day, in the year 2017, and was called to order by the Honorable Mayor, Danny Jones. The invocation was delivered by Councilmember Richardson and the Pledge of Allegiance was led by Councilmember Burton's daughter. ## **MISCELLENOUS RESOLUTIONS**

1. <u>Resolution No. 959-17</u> - A Resolution expressing Charleston City Council support for the passage of West Virginia Amendment #1, Bonds for Roads and Bridges Measure.

WHEREAS, during the 2017 Legislative Session, several pieces of legislation were passed to address improvements to West Virginia roads and bridges in an effort to benefit the West Virginia economy, facilitate tourism, and improve safety throughout the State; and

WHEREAS, the Legislature and Governor Justice have called for an amendment to the Constitution of the State of West Virginia enabling the Legislature to issue and sell state bonds up to \$1.6 Billion to finance the road and bridge improvements; and

WHEREAS, the special election to adopt the Constitutional Amendment will be held of October 7, 2017; and

WHEREAS, the infrastructure projects will create jobs and contribute to economic development; and

WHEREAS, the infrastructure projects will improve the safety of West Virginia's citizens and visitors to our state; and

WHEREAS, the infrastructure projects will aid Charleston in its efforts to improve its image as a destination City for tourism and as an economic hub of West Virginia;

## Be it Resolved by the Council of the City of Charleston, West Virginia:

That the Charleston City Council supports the passage of West Virginia Amendment #1, Bonds for Roads and Bridges Measure, and encourages that citizens of Charleston to vote for the amendment in the special election on October 7, 2017.

Councilmember Burka moved to approve the Resolution. Councilmember Ware seconded the motion. With a majority of members elected recorded thereon as voting in the affirmative the Mayor declared Resolution 959-17 adopted.

## 2. <u>Resolution No. 960-17</u> -

WHEREAS: Charleston and West Virginia, like much of America, has a national health crisis with preventable diseases as the leading cause of death and disability, including 68.8% of Americans are overweight/obese, 70% of deaths in the U.S. are preventable, 86% of all healthcare expenditures are for people with one or more chronic diseases, and \$315.4 billion is spent on healthcare each year treating heart disease and stroke; and

WHEREAS: Seafood nutrition offers significant solutions for all ages, such as lowering the risk of cardiovascular disease, helping expectant mothers to have babies with better outcomes for brain and eye health, and providing higher levels of omega-3 fatty acids in seniors to help them live healthier and longer lives; and

WHEREAS: U.S. Department of Agriculture (USDA) and Health and Human Services dietary guidelines continue to recommend eating seafood at least twice a week for multiple health and nutrition benefits, and more awareness leads to a healthier diet that includes seafood (currently only 10% of Americans consume seafood twice a week); and

WHEREAS: The national non-profit Seafood Nutrition Partnership seeks to educate and encourage citizens to reduce risks of heart disease and improve baby brain wellness by educating Americans about the multiple health benefits of eating more seafood and building awareness of seafood's benefits and nutrients from eating more seafood ; and

WHEREAS: Charleston is one of eight cities nationally to be designated by the Seafood Nutrition Partnership for a grassroots public health campaign to educate and engage people in our city, state, and nation about health and nutritional benefits of seafood; and

WHEREAS: The public education and advocacy of a nutritional diet in year three of the Seafood Nutrition Partnership's public health campaign complements Charleston's other efforts toward becoming a healthier City, combatting obesity and diminishing the incidence of cardiovascular disease in our community.

Therefore be it resolved by The Council and Mayor of The City of Charleston, West Virginia: That we, the elected leaders of Charleston, designate October 2017 as Seafood Nutrition Partnership Month

And, in partnership with coalition members representing healthcare, academia, business and non-profit organizations, we encourage people in our City to take the Healthy Heart Pledge by eating at least two servings of seafood each week as recommended by the USDA Dietary Guidelines for Americans. By participating in this challenge and eating more seafood, we will lower the risk of cardiovascular disease, help expectant mothers to have babies with better outcomes for brain and eye health, and provide higher levels of omega-3 fatty acids in older

Americans to help them live healthier and longer lives.

Councilmember Richardson moved to approve the Resolution. Councilmember Ware seconded the motion. With a majority of members elected recorded thereon as voting in the affirmative the Mayor declared Resolution 960-17 adopted.

An addition of 20 lineal feet of Retaining Wall will be required to tie into an existing concrete retaining wall and prevent future failure of an old stacked stone and mortar retaining wall. An addition of 200 SF Roadway Restoration will be required as well. The City will provide 2 sections of guard rail and the contractor will install them to complete the change order.
