Resolution No. 004-18

Introduced in Council

January 16, 2018

Keeley Steele ...

WHEREAS: In its fifth year as an initiative to encourage people in our community to discover all the great food

options offered at restaurants in our City, Charleston Restaurant Week 2018 will be held from Monday, January 29 to Saturday, February 3 and feature 21 independently-owned restaurants that

add great flavor to life in Charleston; and

WHEREAS: The first Charleston Restaurant Week was created to get consumers back in the habit of eating at

local establishments following the economic devastation that the 2014 water crisis had on people

who worked in, owned and operated restaurants here; and

WHEREAS: While its creation resulted from a crisis, Restaurant Week has grown into a positive community

celebration of the outstanding food options available in Charleston with participating establishments

offering a wide variety of special three-course meals for up to \$30; and

WHEREAS: Six restaurants – Bridge Road Bistro, Ichiban, Paterno's at the Park, Soho's Capitol Market, South

Hills Market & Café and Bluegrass Kitchen – have participated every year of the promotion and will be joined by three first-timers in 2018 along with 12 others that have joined the cause in previous

years as well; and

WHEREAS: The middle of winter usually represents a slow time for the food hospitality industry, but previous

Restaurant Week promotions have led to significant increases in numbers of meals served, greater revenue for our restaurant employers, higher tip income for servers and, according to one credible

estimate, an economic impact within our community of \$500,000.

Therefore be it resolved by The Council and Mayor of The City of Charleston, West Virginia:

That we, the elected leaders of Charleston, do hereby recognize and honor the organizers, participating restaurants and consumers that created, developed and continue to support

in celebration of all of the culinary excellence in Charleston and the economic impact it feeds.

COMMITTEE ON PARKING

Councilmember Harrison, Vice Chair of the Council Committee on Parking, submitted the following reports:

1. Your committee on Parking has had under consideration the following bill, and reports the same to Council with the recommendation that Bill No. 7772 do pass.

<u>Bill No. 7772</u> - A Bill amending and re-enacting Sections 114-622 and 114-623 of the Municipal Code of the City of Charleston, West Virginia, for the purpose of changing the rates for onstreet, metered parking.

Be it Ordained by the City Council of the City of Charleston, West Virginia: That Sections 114-622 and 114-623 of the Municipal Code of the City of Charleston, West Virginia, are hereby amended and re-enacted to read as follows:

Sec. 114-622. - Per-hour parking fees established.

In the areas bounded by Broad Street <u>Leon Sullivan Way</u> on the east, Kanawha Boulevard on the south, Elk River on the west, and Piedmont Road on the north, the rental fee for use of any single on-street metered parking meters at the rate of \$0.50 per hour as required by the instructions printed upon each meter. <u>Beginning on February 5, 2018, and continuing thereafter, the rental fee for use of single on-street metered parking in the following areas will be according to the following schedule with no maximum parking time, as required by the instructions printed upon each meter:</u>

Rate of \$1.00 per hour:

400 block of Laidley Street

500 and 600 block of Donnally Street

Rate of \$.25 per hour:

500 block of Summers Street

700 and 800 block of Donnally Street

500 and 600 block of Capitol Street

600 block of Eagan Street

700 and 800 block of Christopher Street

300, 400 and 500 block of Dickenson St.

300, 400 and 500 block of Leon Sullivan Way

300, 400, 500, 600 block of Morris Street
1200 block of Lewis Street
1000, 1100, and 1200 block of Washington Street
1100and 1200 block of Virginia Street East

Beginning on May 21, 2018, or upon installation of web-based parking meters, whichever occurs later, and continuing thereafter, the rental fee for use of single on-street metered parking, and maximum parking times in the following areas will be according to the following schedule, as required by the instructions printed upon each meter:

Rate of \$1.00 for first hour, \$1.50 for second hour, and an additional \$1.50 for the third hour with a 3 hour maximum time:

100 and 200 block of Hale Street
Unit block of Dunbar Street
200 block of Leon Sullivan Way
Unit block to 400 block of Capital Street
Unit block to 300 block of Summers Street
Unit block to 300 block of Laidley
800 block of Kanawha Blvd.
1000 block of Virginia Street East
500 to 1000 block of Quarrier Street

Provided, where it is determined by the streets and traffic committee that there is a need for further regulation and control of vehicles parking within this area, the city may designate individual on-street metered parking spaces within this area to allow for less than the maximum of two three hours at a rate of not more than \$0.25 <a href="\$\frac{\$0.50}{0.50}\$ per 15-minute increments. Any such parking space shall have the time restrictions and rates printed upon each meter. If the city consents to temporarily bagging or removing a meter to accommodate construction or other activity, the rental fee shall be \$15.00 per day or any portion of a day for each such meter.

Sec. 114-623. - Per-hour parking fee established.

<u>Except as set forth in Sec. 114-622 herein, The</u> rental fee for use of any single on-street metered parking shall be at the rate of \$0.25 per hour as required by the instructions printed upon each meter.

Councilmember Harrison moved to approve the bill. Councilmember Lane seconded the motion. Bill will be voted on under Finance.

COMMITTEE ON PLANNING

Councilmember Harrison, Vice Chair of the Council Committee on Planning, submitted the following reports:

1. Your committee on Planning has had under consideration the following bill, and reports the same to Council with the recommendation that Bill No. 7770 do pass.

<u>Bill No. 7770</u> - Amending the Zoning Ordinance of the City of Charleston, West Virginia, enacted the 1st day of January 2006, as amended, and the map made a part thereof, by rezoning from an R-4 district to an R-6 district, those certain six lots land situate at 1307 Grant Street, 1309 Grant Street, 1311 Grant Street, 1310 2nd Avenue, 1312 2nd Avenue and 1314 2nd Avenue, Charleston, West Virginia.

Be it Ordained by the City Council of the City of Charleston, West Virginia:

1. The Zoning Ordinance of the City of Charleston, West Virginia, enacted the 1st day of January 2006, as amended, is hereby amended by rezoning from an R-4 district to an R-6 district the whole of the following described parcels of land:

Parcels Nos. 117, 118 and 19 as shown on Charleston West Tax Map No. 23. Said tax map is of record in the Planning Office.

Parcels Nos. 122, 123 and 124 as shown on Charleston West Tax Map No. 23. Said tax map is of record in the Planning Office.

- 2. The Zoning Map, attached to and made a part of said Zoning Ordinance, is hereby amended in accordance with Article 27 of this ordinance.
 - 2. All prior ordinances, or parts of ordinances, inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.



Sec. 114-622. - Per-hour parking fees established.

In the areas bounded by Leon Sullivan Way on the east, Kanawha Boulevard on the south, Elk River on the west, and Piedmont Road on the north, the rental fee for use of any single onstreet metered parking meters at the rate of \$0.50 per hour as required by the instructions printed upon each meter. Beginning on February 5, 2018, and continuing thereafter, the rental fee for use of single on-street metered parking in the following areas will be according to the following schedule with no maximum parking time, as required by the instructions printed upon each meter:

Rate of \$1.00 per hour: 400 block of Laidley Street 500 and 600 block of Donnally Street

Rate of \$.25 per hour:
500 block of Summers Street
700 and 800 block of Donnally Street
500 and 600 block of Capitol Street
600 block of Eagan Street
700 and 800 block of Christopher Street
300, 400 and 500 block of Dickenson St.
