### **COMMITTEE ON FINANCE**

Councilmember Reishman, Chair of the Council Committee on Finance, submitted the following reports:

1. Your committee on Finance has had under consideration the following resolution, and reports the same to Council with the recommendation that Resolution No. 112-18 be adopted.

<u>Resolution No. 112-18</u> - Authorizing the Mayor or his designee to receive and administer a grant award in the amount of \$98,500.00 to the WV Governor's Highway Safety Office to fund Drug Recognition Enforcement, e-citation equipment, travel and training as well as overtime patrols for DUI and the Click It or Ticket Program.

### Be it Resolved by the Council of the City of Charleston, West Virginia:

That the Mayor or his designee is hereby authorized and directed to receive and administer a grant award in the amount of \$98,500.00 to the WV Governor's Highway Safety Office to fund Drug Recognition Enforcement, e-citation equipment, travel and training as well as overtime patrols for DUI and the Click It or Ticket Program.

Councilmember Reishman moved to approve the Resolution. Councilmember Ware seconded the motion. With a majority of members elected recorded thereon as voting in the affirmative Council President Lane declared Resolution No. 112-18 adopted.

Change Order No. 23 increases the contract price from \$97,539,912.95 to \$97,640,813.01 and extends the time for substantial completion from September 20, 2018 to September 25, 2018.
