WHEREAS, pursuant to the authority granted by the City Charter, Section 25, and the Code of the City of Charleston, Ordinance Section 2-133, various surety bonds are provided for to cover the faithful performance of certain city officials and personnel;

WHEREAS, the amounts prescribed in the Charter Section 25, and the Code Section 2-133 for the certain bonds are minimum amounts, and whereas the Charter Section 25 provides specifically that Council may require additional bond from any of the said appointive officers;

WHEREAS, traditionally, over the course of years, the City has held in place increased bond amounts on the various positions as listed on Addendum A:

WHEREAS, Mayor-elect Amy Shuler Goodwin, City Manager Appointee Jonathan Storage, and City Clerk Appointee Miles Cary II, have all filled out applications for bonds to be issued in the amounts aforesaid for their respective positions, with the premium amounts being as follows: Mayor--\$150/year; City Manager--\$75/year; and City Clerk \$75/year.

WHEREAS, David Molgaard has served as Charleston’s City Manager for 16 years, the most important and influential office of the City below that of the mayor; and

WHEREAS, David Molgaard participated in planning processes to set over-arching goals and plans to improve and advance the interests of the City of Charleston in core areas, including, strengthening neighborhoods, improving infrastructure, making Charleston a vibrant community through recreation and events, and, perhaps, most importantly, running an efficient city government; and through David Molgaard’s leadership, these goals and plans were integrated in the overall operations of each department of the city and thereby achieved major goals; and

WHEREAS, Paul Ellis has been a key participant in implementing over-arching goals and plans to improve and advance the interests of the City of Charleston in core areas, including, strengthening neighborhoods, improving infrastructure, making Charleston a vibrant community through recreation and events; and

Bill No. 7800 - A Bill to establish a No Parking Tow-Away zone on both sides of Sunset Drive from the intersection of South Drive to a point 650 feet to the northwest and amending the Traffic Control Map and Traffic Control File, established by the code of the City of Charleston, West Virginia, two thousand and three, as amended, Traffic Laws, Section 263, Division 2, Article 4, Chapter 114, to conform therewith.

Be it Ordained by the Council of the City of Charleston, West Virginia:

Section 1. A No Parking Tow-Away zone on both sides of Sunset Drive from the intersection of South Drive to a point 650 feet to the northwest.

Section 2. The Traffic Control Map and Traffic Control File, established by the Code of the City of Charleston, West Virginia, two thousand and three, as amended, Traffic Laws, Section 263, Division 2, Article 4, Chapter 114, shall be and hereby are amended, to conform to this Ordinance.

Section 3. All prior Ordinances, inconsistent with this Ordinance are hereby repealed to the extent of said inconsistency.
