The COVID-19 pandemic as negatively impacted every level of education in West Virginia since it first surfaced in the Mountain State last spring. Although devastating to public education, it had an adverse effect on athletics. After the schools close on March 13, 2020, the states concerns turned not to just educating students, but also attending to their basic needs. Before the pandemic, the state served 500,000 meals in the summer of 2019. In the summer of 2020, the state served 8 million meals to the students. For obvious reasons, the basic needs of the student were of higher importance than athletics, which were place on hold. Grape Juice Ventures, LLC. ("Grape Juice") seeks to acquire property and develop an indoor Athletic Complex ("Facility") to provide a venue for area youth and the community to re-engage in athletics in a more robust and meaningful manner. Charleston, Kanawha County and Southern West Virginia are sorely lacking in a quality indoor athletic facility. In comparison, cities and communities throughout the South and mid-Atlantic have developed athletic facilities to promote the quality of life and enhance economic development in their communities. The reality is that there are no quality athletic facilities in Southern West Virginia to serve the youth and residents at a competitive level. The envisioned Facility can substantially enhance the overall quality of life in our community. Grape Juice Ventures proposes to acquire existing property and renovate it to house Facility or acquire land to build the Facility. The Facility will have, at a minimum, 6 regulation basketball courts, which can be used interchangeably as volleyball courts, with suitable seating for spectators. This space will also be suitable for other indoor sports and activities. The goal of the Facility is to provide a first rate environment for the community while attracting teams, players and spectators to the Charleston/Kanawha County market to generate revenue for the Facility and to create a positive economic impact through direct and indirect spending ("Multiple Effect") in the community. In addition, it is Grape Juice Venture's expectation that overall quality of life will be improved, all of which will help in their retention of residents, increase tourism and enhance economic development.
